### **SCOPE OF WORK FOR THE REPAIR OF THREE FIBER OPTIC CABLES BETWEEN DISTRIBUTION CENTERS**

- Repair of All-Dielectric Self-Supporting (ADSS) fiber optic cable between Botshabelo B and Botshabelo K.
- Repair of ADSS fiber optic cable within the yard at Parkwest DC.
- Repair of fiber optic cable at Willows DC, located inside the stormwater channel adjacent to the Willows Distribution Centre.

#### **1 Repair of Fiber Optic Cable Between Botshabelo B and K Distribution Centres**

The scope of work includes the repair of the fiber optic cable between Botshabelo B and Botshabelo K Distribution Centres and comprises the following activities:

- 1.1 Replacement of the dome joint on a 33 kV wooden structure, located approximately 1.8 km from Botshabelo K Distribution Centre, accommodating a 12-core single-mode ADSS fiber.
- 1.2 Splicing of the 12-core ADSS single-mode fiber at the dome joint in accordance with industry standards.

- 1.3 Reinstallation of the dome joint on the wooden structure at a height of approximately 8 metres above ground level.
- 1.4 Performance of OTDR testing between Botshabelo B and Botshabelo K Distribution Centres, conducted from both ends to verify link integrity.

### **Additional Information**

- A ladder with a minimum height of 8 metres is required to access the dome joint.
- Botshabelo A is located approximately 65 km from Bloemfontein.

## **2 Repair of ADSS Fiber Optic Cable at Parkwest DC**

The scope of work includes the following activities:

- 2.1 Removal of approximately 85 metres of damaged ADSS fiber optic cable.
- 2.2 Replacement of the dome joint on the 132 kV structure.
- 2.3 Splicing of 12-core ADSS single-mode fiber at the dome joint.
- 2.4 Installation of approximately 80 metres of orange 50 mm High-Density Polyethylene (HDPE) pipe in the cable trenches.
- 2.5 Installation of approximately 85 metres of ADSS fiber optic cable in the cable trenches (fiber optic cable to be supplied by Centlec).
- 2.6 Splicing and termination of 12-core single-mode fiber in the patch panel using ST connectors.
- 2.7 OTDR testing between Parkwest DC and Western Line T DC, conducted from both ends.

### **Additional Information**

- The fiber optic cable must be installed in existing cable trenches.
- The HDPE pipe must be installed within the cable trenches.
- A 25-metre section of the trench is currently covered with soil and must be cleared to a depth of 200 mm and a width of 500 mm.
- The dome joint on the structure must be installed at a minimum height of 5 metres above ground level.
- Parkwest DC is located at the end of Walter Sisulu Drive, approximately 300 metres from the N1 bridge.
- Western Line T DC is situated approximately 1.5 km from Parkwest DC.
- Images 2 and 3 illustrate the damaged fiber optic cable.

### **3 Repair of Fiber Optic Cable at Willows DC**

The scope of work includes the repair of the fiber optic cable at Willows DC and consists of the following activities:

- 3.1 Removal of approximately 160 metres of existing fiber optic cable.
- 3.2 Installation of approximately 160 metres of fiber optic cable within the existing cable trenches and conduits (fiber optic cable to be supplied by Centlec).
- 3.3 Replacement of the dome joint located inside the stormwater channel, accommodating a 12-core single-mode fiber.
- 3.4 Splicing of 12-core single-mode fiber at the dome joint within the stormwater channel.
- 3.5 Splicing and termination of 12-core single-mode fiber in the patch panel using ST connectors.
- 3.6 Performance of OTDR testing of the fiber link between Willows DC and Parkwest DC, conducted from both ends.

#### **Additional Information**

- The stormwater channel is approximately 3 metres high and 3 metres wide.
- The existing fiber optic cable is damaged at the dome joint and is too short to be re-jointed; therefore, the installation of 160 metres of new fiber optic cable to the patch panel is required (fiber optic cable to be supplied by Centlec).
- Approximately 300 mm of standing water is present at the bottom of the stormwater channel, and prospective bidders must be prepared to work under these conditions.
- Willows DC is located at the corner of Park Avenue and Parfitt Avenue.
- Refer to Image 4, which illustrates the vandalized fiber optic cable inside the stormwater channel.

## TAX CLEARANCE CERTIFICATE REQUIREMENTS

## CERTIFICATE OF INDEPENDENT BID DETERMINATION
