ELECTRICITY TARIFFS FOR THE PERIOD 1 JULY 2023 – 30 JUNE 2024

Your application dated 14 June 2023 refers.

The Energy Regulator at its meeting held on 02 June 2023 approved the guideline increase of 15,10% for municipalities applicable for 2023/24 financial year. Consequently, the Energy Regulator considered your application for a tariff increase for the period 1 July 2023 - 30 June 2024 and approved the tariffs as follows:
